#### **SHOW INFORMATION:**

1. Location: Edna Vihel Activities Center, 3340 S. Rural Rd. Tempe, AZ 85282 and the Tempe History Museum 809 E. Southern Ave., Tempe, AZ 85282 (NE corner of the Tempe Public Library & History Museum complex located on the SW corner of Rural Rd./Southern Ave.).
2. Dates and times: Saturday, March 3, 2017 from 8am until 3pm.
  - a) Dealers will be allowed in for set-up on Friday, March 2nd from 6pm until 8pm & at 6am on Saturday for Early Birds preparation.  
Early Birds show is from 7am-8am on Saturday. Early Birds Entry Fee: \$5.00. Regular show is from 8am to 3pm on Saturday. Entry fee is \$3.00.
  - b) Dealers must be packed and out of the facility by 5:00 pm. Dealers may not pack up wares until closing of show, 3pm.
3. **TUESDAY, FEB. 20 DEADLINE** for space reservations, or will close when full. Contract must be POSTMARKED OR RECEIVED with full payment on or before, **FEB. 13, 2018** to avoid late fee. Contracts postmarked or received after February 13, 2018 will be subject to a late fee of \$15.00 per space. **NO REFUNDS AFTER TUESDAY, February 20, 2018.**

#### **TERMS OF THIS AGREEMENT:**

- 1) General: The acceptance of this reservation by Hayden's Ferry Questers is conditional upon the acceptance of DEALER to be bound by the terms of this agreement and the terms of the agreement that Hayden's Ferry Questers has with the Edna Vihel Activities Center, Tempe History Museum and the City of Tempe for SHOW space.
- 2) Definitions:
  - a) "Set Up": Time period provided to DEALER to unload and display wares in preparation for SHOW.
  - b) "Pack Up": Time provided to DEALER to remove unsold wares from the SHOW premises. It is a specific condition that DEALER may **NOT** remove such wares prior to 4:00pm on Saturday, March 25 and be vacated no later than 6:00pm on Saturday, March 25.

- 3) DEALER is solely responsible for ensuring that their table(s) is/are manned **AT ALL TIMES** during show hours. **DEALER MAY NOT SHARE OR FURTHER SUBLEASE ANY SPACE(S)** without the expressed written consent of Hayden's Ferry Questers.
- 4) If applicable, DEALER is responsible for securing/having any and all necessary permits and licenses to sell at this SHOW and DEALER shall be solely responsible for the collection and remittance of any and all sales/use taxes to the proper authorities.
- 5) As part of this agreement, DEALER hereby expressly assumes the responsibility for any and all lost, damaged or stolen wares and DEALER hereby expressly agrees to hold harmless Hayden's Ferry Questers, Edna Vihel Activities Center, Tempe History Museum or City of Tempe from any and all such claims, however styled. DEALER is strongly advised to take extra ordinary precautions to secure and/or protect any valuable items from the period of setup to pack up. **24 HOUR SECURITY IS PROVIDED**
- 6) Electricity may be available for wall spaces on a limited basis, but DEALER must provide their own extension cord/s. **Electricity needed: YES\_\_\_\_\_ NO\_\_\_\_\_**
- 7) DEALER hereby expressly assumes responsibility for any damage DEALER causes to the facilities. **HANGING ANYTHING FROM THE WALLS IS ABSOLUTELY FORBIDDEN!**
- 8) DEALER must furnish table cover(s) for their tables.
- 9) DEALER understands that due to the nature of the collectibles involved, all reproduction, repaired or otherwise altered wares, must be clearly labeled, offered and/or sold as such.
- 10) DEALER further understands that ANY violation of this agreement by DEALER or any action(s) by DEALER that would violate Hayden's Ferry Questers agreement with the Edna Vihel Activities Center, Tempe History Museum and the City of Tempe shall be cause for DEALER to be ejected from this SHOW (without any space monies refunded) and same will be grounds for prohibiting DEALER from participating in future shows sponsored by Hayden's Ferry Questers.
- 11) DEALER agrees that Hayden's Ferry Questers shall not be responsible for matters outside its expressed control and the liability of Hayden's Ferry Questers in any case shall be limited to the refund of any monies paid by DEALER to Hayden's Ferry Questers for this SHOW.
- 12) DEALER understands the show is a **fund raiser for Tempe's Petersen House** with all proceeds from the SHOW going to the continuing restoration of the Petersen House.

By execution of this agreement, the undersigned DEALER hereby certifies that they have read and agree to abide by the terms of this agreement and the overriding terms of the agreement of Hayden's Ferry Questers with the Edna Vihel Activities Center, Tempe History Museum and the City of Tempe.
